### **Job description**

#### **Responsibilities:**

- Assist with completion of installation reports and paperwork;
- Maintain tool management standards;
- Any other duties as may be required from time to time.

For the purpose of meeting the requirements of this role, the employee will be required to operate power tools, lift and or carry equipment and tools, work from ladders, scaffolds and roofs, working in cramped workspace and outdoors subjected to weather conditions. The employee may be required to drive the Company vehicle.
